



- To accept the management of any trust shall have also the power to frame rules and byc laws under its constitution.
- To assist a government programs in its implementation and to run them with the help of the state.
- To accept any gift, grants donations, contribution or subscription for the promotion of the trust and to issue appear, applications for money and funds.



- To fulfill its objectives, the trust shall procure help from the government, non-government, and other organizations within the country & abroad. Further the Trust may take loan or advance from its member or from Bank/Financial Institutions at reasonable rate of Interest for fulfilling its object.
- Area of operation shall be the whole India.
- As and when required, the Trust may open a Branch office at any place or places as may be decided by the Trustees.
- Minimum number of Trustees shall be Three and maximum number of member shall be ter subject to approval from Board of Trustees.

The Trust shall be irrevocable.

AND WHEREAS the trustees have agreed individually and collectively to set as such and have already taken possession of the said cash, in pursuance of the aforesaid desire of the Author of the trust, who has irrevocably transferred and handed over the same to the trustees for the purposes of the trust as foresaid.

#### NOW THEREFORE THE DEED OF TRUST DECLARES AND WITNESSETH:-

This in pursuance of the promises, the Author of the trust as settler both hereby convey unto an settle upon the trustees all the cash, hereto hold the same upon trust



And the Trustees do and each of them both hereby admit and acknowledge the transfer there of them with power and subject to the use mentioned here in after.

- 1. The name of the trust shall be "SRI RAM EDUCATIONAL TRUST" a Publ Charitable trust, with its registered office at Plot No. 372, Village Mustafapur, P.S Maniyarpur, District: Vaishali, Bihar. Pin Code: -800453".
- 2. The trust has been established for the purpose and objects lay down above.
- 3. The Author of the trust shall also function as a member of the board of trustees.
- 4. The trustee shall stand possessed of the cash, hereby conveyed and settled upon an shall use and apply the interest. The profits and the other income derived thereby for the purpose and object of the trust as aforesaid.
- 5. The cash herby conveyed to the trustees shall form the corpus of the trust propert but the trustees shall have power from time to time to increase or decrease the corpu according to the best of their judgment.
- 6. The trust shall be governed by a board of Trustees. In the event of death, incapacit insolvency, resignation, the remaining trustees shall be entitled to



nominate any other person as they think fit and proper to act as trustee in place of the trustee so died incapacitated, declared insolvent, resigned or refused to act as such.

- 7. The nomination of any person as a trustee shall be either unanimous or by a majority decision and in the event of the trustees being equally divided on the nomination of any person, the decision in the matter of the Managing Secretary shall be final and conclusive.
- 8. The administration of the trust hereby constituted and the entire control, supervision, regulation, management of the trust property and even the application of the entire of apart of the income and the profits there of as also of all the donation and contributions and subscriptions, if any received by it shall vest in the uncontrolled discretion of the Board of Trustees subject however always to the provisions contained as herein before.
- 9. The Board of trustees may frame rules and regulations for the administration of the trust and for carrying out the purpose and object there of and the same may be varied, altered, substituted or added to from time to time by a unanimous decision of the Board of Trustee with a view to introduce more effective administration and carrying out the purpose and the object of the trust, such rules may specifically provide the basis or criterion of the selection of the beneficiaries although preference may be given in such section to the people belonging to the weaker sections of the society.
- 10. The Board of Trustees shall have power to accept donation, contribution grant or subscription from others in cash or kind with or without any special conditions attached there to provided that any such condition does not contravene the provisions of clause 2 here of. Subject to the same restrictions, the board of constituted trust has declared.
- 11. The Board of trustees may elect or nominate any one of them as the Managing Secretaries for any period of time. The first Managing Secretary shall be Mr. Kamaljee Arora and he shall hold that office and position up to the time of his death, incapacity insolvency, resignation or refusal to act as such.
- 12. The Board of Trustees may also appoint or nominate any one of them, treasurer or any other office bearer from time to time to manage the activities of the trust.
- 13. The board of Trustees may also, form a body of governing council or any such body for smooth running of activities or their areas of operation.
- 14. The First Meeting of the Board of Trustees shall be held within three months of the date of the execution of this deed and shall be summoned by Settlor of the trust by giving at least seven days' notice in writing to all the trustees held at such place and time as may be specified in the notice and in that meeting all relevant matters relating to the trust shall be considered in all possible details and particularly the ways and the manner to give effect to the provisions of the deed of trust to attain the object an purpose of this trust.



- The Board of Trustees is empowered to open account in the name of the trus trustees and/or institution run conduced by the trust with a Bank or Banks. Further th Bank Account/Accounts will be operated by the Managing Secretary and/or any other Individual(s) as decided by the Board of Trustees from time to time in the larger intere of the Trust.
- The trustees may in their uncontrolled discretion deposit for safe custody ar documents or securities relating to or forming part of the trust property with the bank banks as aforesaid on payment of such charges therefore, if any as may be agreed upon and found expedient in the interest of the trust.
- Meeting of Board of Trustees may be held at such time, at such place and on suc 17. dates as may be agreed upon by the trustees. Such meetings may be summoned by managing trustee or any trustee by giving at least 21 (twenty one) days notice in writin Quorum of every meeting will be 1/3 of the total strength of the Board.
- The Accounting year of the Trust shall be the financial year ending on 31st Marc every year. The Books of Accounts of the Trust will be audited by practicing Charters Accountants every year. The auditors will be appointed in the properly called an resolved meeting of the Board of Trustees.
- If the trustees differ with one another in respect of any such matter with reference which they enjoy discretion the opinion of the majority of the trustees present or voting at the meeting shall prevail and shall be binding on all the trustees, and in the event the trustees being equally divided the view taken by the Managing Secretary sha prevail in deciding such matter. If any trustee defer with the decision of the Board and record his/her objection, in such situation the Trustee will not be liable for any loss any other liabilities what so ever incurred.
- The objects of the Trust shall be such of those that will make it eligible f 20. exemption from Income Tax under the provisions of income Tax Act, 1961 as amende from time to time.
- The Board of trustees may appoint constituted attorneys or agents and to delegasuch attorney or agents all or any of the powers vested on them under these presents an from time to time remove such attorney or agents and to appoint other in his or the place.
- With the consent of Board of trustee in absolute majority, any clause of the tru may be amended / changed in the larger interest of the Trust.
